New Business

- Updated that PTSO was not successful in adding the new treasurer to the current Wellsfargo bank count. Pete suggested to amend the bylaws to open another bank account with any financial institution. Angelique asked why PTSO was having issues switching the account. PTSO expressed that we were listed as a non-profit and we are not considered as a non profit and did not have the correct documentation, such as the meeting minutes with all board members signatures and other forms. Nora motioned to amend the bylaws to be able to open an account with any FDIC insured financial institution, limited to one account at a time. Arlene seconds motion. All voted in favor. Vote passed
- Vote on snack bar Friday's and an amount. Discussed on what the funds raised from the Friday snack bar would be used for. Discussed on funds being allocated for general school support. Nora made a motion to start snack bar Fridays on September 20th with the amount being able to spend \$800. Funds received from snack bar will be allocated for general students school support. Jacque, second motion. All voted in favor. Vote passes.
- Fundraising for the Fall Festival. Discussed on the date being Nov. 15, 2024 5:30pm-8pm. Nora discussed on doing penny wars, AP Rodman discussed on doing dippin dots. Ana suggested

doing both. Jaque reminded the board of having deadlines' for the permits. Ana will call Brenda to get permit fees/ station information and dates. Nora motioned to have the dipping dots fundraiser on Sep. 18th. Ana seconds. All voted in favor. Nora amended the motion to do the fundraiser on dates between tomorrow 9/10 through 10/2. Ana seconds. All voted in favor. Vote passes. Motioned to do penny wars Sep 23rd through the 27th. Ana seconds. All voted in favor. Vote passes.

- Discussed doing the Mrs. Fields cookie fundraiser and strategies to do it differently from last year. Such as doing an assembly or joining the teacher's professional development meetings.
